# ZERO TOLERANCE FOR BULLYING AND INAPPROPRIATE BEHAVIOUR

The Science Quest camp environment is inclusive and enjoyable for all children. Science Quest has enacted a zero tolerance policy for bullying and inappropriate behaviour to ensure the safety and full participation of all campers. Campers will be removed from camp if they violate this policy, with no refund.

Science Quest will not tolerate physical harm of another individual, malicious or offensive teasing, the use of abusive, vulgar, and inappropriate language, stealing or the intentional vandalism of materials and/or property of the university, Science Quest or campers, or the use of illicit substances while on university property and under the care of the camp.

The Science Quest employees involved will have ultimate authority to determine the consequences of a camper's actions; their decision will be final. Your signature at the end of this document acknowledges that you are aware of the Bullying and Inappropriate Behaviour Policy.

## **COMPUTER USE AGREEMENT – COMPUTER CAMP ONLY**

Campers are encouraged to explore and publish relevant Internet content to better understand the uses and implications of technology. However, the internet allows for access to things that are not appropriate in a camp setting. While Science Quest staff will make all reasonable precautions to restrict the access of questionable material, the possibility of intentional or inadvertent access still exists. Science Quest has therefore enacted a policy to restrict the participants' access of inappropriate material during camp, monitor computer use and encourage a positive learning environment.

The following violations will lead to disciplinary action in the form of a 'strike', a phone call to the parents/guardians or possible suspension/expulsion from Science Quest with no refund.

- Accessing or publishing explicit/pornographic material
- Harassing other users
- Modifying another users' network account space
- Vandalism of accounts and systems •
- Using abusive, vulgar or otherwise inappropriate language •
- Illegally distributing or downloading copyrighted material •
- Any other action deemed inappropriate by a Science Quest employee •
